TF726 KIMIFUKU ist der Sohn von KIMIFUKU 3 (90KURO 1172, DOB 8 May 1990).

KIMIFUKU 3 war der best marmorierende Bulle in der Geschichte von Mr. Takedas Wagyu-Zucht.

Das durchschnittliche Schlachtgewicht seiner Nachfahren liegt bei 437kg (BMS 9.2/12 und der A5 Ratio bei 25 Schlachtkörper ist 100%).

Mr. Takeda wusste dass der beste Tajima (Naka-Doi) Bulle eine Kombination aus Itsuhime, Kikutsuru und Mitsufuku sein musste. Zu diesem Zeitpunkt wäre der Wert eines solchen Bullens bei rund JPY10,000,000 gelegen. In den 90er erhielt Mr. Takeda diesen Bullen von seinem Freund Mr. Sebukami. Er samte den Bullen ab und bekam zusätzlich noch 21 weibliche und 25 männliche Kälber (Naturesprung). Alle 25 männlichen Tiere wurden gemästet und hatten sehr gute Schlachtkörper (siehe Ergebnis oben).

TF726 KIMIFUKU is the son of KIMIFUKU 3 (90 KURO 1172, DOB: 8 May 1990). KIMIFUKU 3 is the best marble Wagyu bull in the Mr. Takeda's Wagyu history.

Average carcass weight is 437Kg, BMS 9.2/12 and A5 ratio is 100% (25 carcasses)

Mr. Takeda knows that the best Tajima (Naka-Doi) bull is the combination of Itsuhime, Kikutsuru and Mitsufuku dams and kept looking for this kind of bull which valued about JPY10,000,000 in 1990's. Mr. Takeda was lucky enough to get this bull in favour of his friend, Mr. Sebukami and collected 3,000 straws and got 21 heifer and 25 steers by natural joining. All steers were feed-lotted and got excellent result as above, but KIMIFUKU was dead by fat necrosis in 1993, which happens sometimes especially high marbling bull.
